The regular meeting of the Board of Trustees for the Burlington Public Library was called to order by Vice President Don Schmidgall, Wednesday, August 21, 2024, at 4:30 p.m. in Meeting Room A. Board members Don Schmidgall, Jennifer McMillan, Brandon Orth, Roger Hatteberg and Library Director Brittany Jacobs were present. Friends Liaison Anita Wagner, West Burlington Liaison Rebecca Teater, and library staff Sara Garland and Kathy Gerling were also in attendance. Board members Becky Godfrey, Mary Weinand and Amanda Mansheim were absent. Notification for this meeting was sent to KBUR/KGRS, KCPS, KKMI, and WIUM radio stations and The Hawk Eye, on August 19, 2024.

Brandon Orth moved the Board to approve the agenda for this meeting and the minutes from the last meeting. Second by Roger Hatteberg; motion approved unanimously.

## **Expenditures**

The final financial report for the FY24 budget was included in the board packet (Budget Control Status Report for accounting period 13/24). We spent 99.86% of our budget.

Brittany explained some of the bigger FY25 expenses as shown on the Budget Control Status Report for period 2/25: Wyebot Wi-Fi sensors and OCLC interlibrary loan and cataloging renewal. There was some discussion about the light ballast fix and the cost associated with it.

Jennifer McMillan moved the Board to approve expenditures. Second by Brandon Orth; motion approved unanimously.

## Friends Liaison

Anita Wagner briefed the Board. The recent book sale at the Very Vintage Market was very successful, raising \$400. The Friends are working on board position descriptions and gearing up for their next book sale in September.
